Sub: Violation of Public Procurement Rules 2004, Divisional Superintendent Workshops,
Pakistan Railways, Mughalpura's Tender Notice for Special Repair Works.

Dear Sir,

This is with reference to Pakistan Railways, Mughalpura's Tender Notice, published in the "The News" on 29th December, 2015. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per the advertisement, "The Railway administration reserves right to accept/ reject any or all the tenders without assigning any reason thereof". It is a violation of PPRA Rules 2004, Rule No.33 (1). Stated as under:

33. Rejection of bids. - (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
