Sub: Violation of Public Procurement Rules 2004, PSP, Deputy Inspector General, Pakistan Railways Police, Lahore's Tender Notice for Contract of Mess of Railway Police.

Dear Sir,

This is with reference to Pakistan Railways Police, Lahore's Tender Notice published in daily "Nawaiwaqt" on 7<sup>th</sup> January, 2015. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per advertisement, the due date for submission of tender is given as 22-01-2015, while the opening of tender is kept after 4 days, that is, 26-01-2015, which is violation of Public Procurement Rules 2004, Rule 28(1). The Rule is quoted below for your reference.

*28. Opening of bids. – (1) The date for opening of bids and the last date for the submission of bids shall be the same. Bids shall be opened at the time specified in the bidding documents. The bids shall be opened at least thirty minutes after the deadline for submission of bids.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
