**Sub: Violation of Public Procurement Rules 2004, Director (Haji), Directorate of Haji,
Ministry of Religious Affairs & Interfaith Harmony, Peshawar's Tender Notice for
Transportation.**

Dear Sir,

This is with reference to Ministry of Religious Affairs & Interfaith Harmony, Peshawar's Tender Notice published in daily "Nai Baat" on 2nd June, 2017. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per the advertisement, there is no information regarding issuance of bidding documents for bidders, which is violation of PPRA Rules 2004, Rule No. 23 (1) & (2). Stated as under;

23. Bidding Documents: - (1) Procuring agencies shall formulate precise and unambiguous bidding documents that shall be made available to the bidders immediately after the publication of the invitation to bid.

(2) For competitive bidding, whether open or limited, the bidding documents shall include the following, namely:-

- (a) invitation to bid;
- (b) instructions to bidders;
- (c) form of bid;
- (d) form of contract;
- (e) general or special conditions of contract;
- (f) specifications and drawings or performance criteria (where applicable);
- (g) list of goods or bill of quantities (where applicable);
- (h) delivery time or completion schedule;
- (i) qualification criteria (where applicable);
- (j) bid evaluation criteria;
- (k) format of all securities required (where applicable);
- (l) details of standards (if any) that are to be used in assessing the quality of goods, works or services specified; and
- (m) any other detail not inconsistent with these rules that the procuring agency may deem necessary.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

GENERAL TERMS AND CONDITIONS:

- All the registered national transport companies can quote their bids.
- Tender should be typed and handwritten tender will not be accepted.
- All the vehicles should be in excellent condition in the company's name.
- All expenses incurred on maintenance/registration/fuel etc. and all other liabilities are to be borne by the contractor.
- Fully trained Drivers having at least five years heavy duty license and experience must be detailed on vehicles in proper dress.
- All the vehicles will be inspected by the designated team at least 07 days prior to put in the operation. At least 08 buses would be stationed round the clock at the Hajj Complex.
- All charges like parking fee, space charges by CAA or other agencies are to be borne by the contractor.
- Copies of CNIC of the owners of the company and NTN certificate may be annexed with tender documents.
- Security Deposit of Rs.100000/- in the shape of bank draft in favour of Director Hajj, Directorate of Hajj Peshawar will be attached with the bid.
- Government taxes will be deducted at the time of payment.
- The sealed tender should reach this office on 20.06.2017 upto 1100 hours to be opened in presence of all the bidders/their representatives on the same day at 1200 hours.
- The Procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the ground for its rejection of all bids or proposals, but is not required to justify those grounds.
