Prequalification of Firms for digitizing of operations room or related works.

Dear Sir,

The Prequalification Notice for Firms for digitizing of operations room or related works published in Dawn on **6** April 2011 is lacking Transparency and violating the "Public Procurement Rules, 2004".

MSA is required to provide set of documents for all prequalifications, under PPRA Rule 16 which shall include all requirements of MSA, and terms and conditions.

## Pre-qualification process.-

- (1) The procuring agency engaging in pre-qualification shall announce, in the pre-qualification documents, all information required for pre-qualification including instructions for preparation and submission of the pre-qualification documents, evaluation criteria, list of documentary evidence required by suppliers or contractors to demonstrate their respective qualifications and any other information that the procuring agency deems necessary for pre-qualification.
- (2) The procuring <u>agency shall provide a set of pre-qualification documents</u> to any supplier or contractor, on request and subject to payment of price, if any.

Public Procurement Rules, 2004 have eliminated all discretions in procurement process and avenues of corrupt practices in tendering.

TI Pakistan again request MSA to detest from violating PPRA Rules, and re-advertise this prequalification and provide set of prequalification documents under rules 16(2).
