Kindly refer to your letter dated October 18, 2012 on the subject noted above.


1. Para-wise reply to the allegations is as under:-
 - a. NADRA invited a public tender for the said requirement, which was published in Daily Dawn and Jang on January 6, 2012 copy attached as Annexure 'A' and 'B' for providing equal opportunity to all. All vendors were given fifteen days time, as per PPRA Rules; hence there was no restriction on any firm/bank.
 - b. As mentioned above, the said tender was an open/public tender with equal opportunity for all Exchange Companies.
 - c. NADRA has not violated or operated against any rules and regulations, neither has barred any firm or bank from replying to the public tender invited.

d. It will not be a justified statement to call this agreement collusion between NADRA and any other firm. Since tender was open public invitation to compete amongst firms and banks.

2. It is pertinent to mention that NADRA, by inviting a public tender ensured to abide by the key factors as suggested by the TI-P, pointed out in the Supreme Court of Pakistan's judgment given in the Rental Power Plants Case on March 30, 2012.

3. NADRA is constantly striving to provide services for the betterment of the nation while remaining in strict compliance to the Rules and Regulations suggested by PPRA and in the constitution of Pakistan.
