This is with reference to the NEPRA's subject decision dated 03.01.2017.

AKLA submitted various important points in the matter of monthly Fuel Charges Adjustment for K-Electric Limited for November 2016 vide letter No.C/NEPRA/788/16 dated 26.12.2016 one day before the Public Hearing held on 27.12.2016. AKLA's points were not considered in the decision of NEPRA for the month of November, 2016.

AKLA are submitting their points/issues in detail continuously for the last two years in the matter of monthly Fuel Charges Adjustment. NEPRA is ignoring AKLA's points/issues in its decisions of monthly Fuel Charges Adjustments. If NEPRA considers that the highlighted issues are not material, it should at least record the same in its' decision so that AKLA can correct their position in the light of the response of NEPRA.

It may be noted that AKLA are highlighting only those issues, in the public interest, which are adversely affecting the consumers of electricity in Pakistan and the economy of the country.
