Sub: Violation of Public Procurement Rules 2004, Commanding Officer, Pakistan Navy,  
PNS Haider, Karachi's Expression of Interest Notice for Provision of Conservancy Services.

Dear Sir,

This is with reference to Pakistan Navy, PNS Haider, Karachi's EOI Notice, published in daily "The Nation" on 21<sup>st</sup> June, 2016. It is observed that the advertisement is in violation of the PPRA Rules 2004.

As per advertisement, 15 days of response time is not given and the date for submission of tender offers/ EOI is given as 30-06-2016, which is 5 days short. It is a violation of Public Procurement Rules 2004, Rule No.13 (1). Stated as under;

*13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the EOI under the prescribed procedures or issue a corrigendum and extend date accordingly.
