This is with reference to National Highway Authority, Lahore's Tender Notice published in daily "The Nation" on 14<sup>th</sup> August, 2018. It is observed that the advertisements are in violation of the PPRA Rules 2004.

As per advertisement, the bid security amount is given as 20%, which is violation of PPRA Rules 2004, Rule 25. Stated as under;

***25. Bid security.*** - *The procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the bid price.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
