Sub: Violation of Public Procurement Rules 2004, General Manager (M-4), National Highway Authority (NHA), Lahore's Tender Notice for Site Clearance by Tractor.

Dear Sir,

This is with reference to NHA, Lahore's Tender Notice published in daily "The Nation" on 14th January, 2016. It is observed that the advertisement is in violation of the PPRA Rules 2004.

As per advertisement, "blank tenders can be obtained on 29-1-16". It is violation of Public Procurement Rules 2004, Rule No. 23 (1). Stated as under;

23. Bidding documents. - (1) Procuring agencies shall formulate precise and unambiguous bidding documents that shall be made available to the bidders immediately after the publication of the invitation to bid.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
