Sub: Violation of Public Procurement Rules 2004, General Manager (Northern Areas), National Highway Authority, Abbottabad's Tender Notice for Deployment of Security Guards.

Dear Sir,

This is with reference to National Highway Authority, Abbottabad's Tender Notice, published in daily "The News" on 13th October, 2015. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per advertisement it is stated that "the tender should reach in the office on 26-10-15, and tenders will be opened on 27-10-15". It is violation of PPRA Rules 2004, Rule 28(1). Stated as under;

28. Opening of bids. – (1) The date for opening of bids and the last date for the submission of bids shall be the same. Bids shall be opened at the time specified in the bidding documents. The bids shall be opened at least thirty minutes after the deadline for submission of bids.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
