**Sub: Violation of Public Procurement Rules 2004, Deputy Director (Establishment/ Transport),
National Highway Authority, Islamabad's Short Tender Notice for Hiring of Coaster.**

This is with reference to NHA, Islamabad's Short Tender Notice, published in daily "The News" on 17th February, 2019. It is observed that the advertisement is in violation of the PPRA Rules 2004.

1. As per advertisement, bidders are required to submit 10% of bid amount (refundable) accompanied with the bids, which is violation of PPRA Rules 2004, Rule 25. Stated as under;

25. Bid security. - The procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the bid price.

2. Also, "NHA reserves the right to reject any or all the bids without assigning the reason." It is not complying with PPRA Rules 2004, Rule No. 33, which requires that reason should be communicated to bidders. Stated as under:

33. Rejection of bids:- (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

3. Agreement will commence from the date of approval of Competent Authority with initial period of one year Coaster offered must be in good road worthy condition, Competent Authority may wish for physical inspection before approval.
4. Pay Order/Demand Draft equal to 10% of bid amount (Refundable) must accompanied with the bids/quotations. The rates quoted shall remain valid for at least six months, Payment of bill will be made after deduction of income tax as per government rules.
5. An affidavit that the firm is not previously blacklisted by any government or semi-government Organization is required to be submitted. Any false information submitted shall make the firm liable for depriving from instant & future contracts in NHA.
6. NHA reserves the right to reject any or all the bids without assigning the reason.
