Sub: Violation of Public Procurement Rules 2004, Director (Establishment), National Highway Authority Islamabad's Tender Notice for Hiring of Coaster.

Dear Sir,

This is with reference to Director (Establishment), National Highway Authority Islamabad's Tender Notice, published in daily "Dawn" on 18th November 2013. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

1. As per advertisement, NHA is not issuing any bidding documents which is Violation of Rule No. 23(5)

23. Bidding Documents:- (5) The procuring agency shall provide a set of bidding documents to any supplier or contractor, on request and subject to payment of price, if any.

2. Also, NHA is asking for 10% of bid amount (Refundable) to be accompanied with the bids/ quotations, which is violation of Rule No. 25, stated as under:

25. Bid security.- The procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the bid price.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50 and with request to re-invite the tender under the prescribed procedures of Public Procurement Rules 2004 or issue a corrigendum and extend date accordingly.

 4. Pay Order / Demand Draft equal to 10% of bid amount (Refundable) must be accompanied with the bids / quotations. The rates quoted shall remain valid for atleast six months. Payment of bill will be made after deduction of income tax as per government rules.
 5. An affidavit that the firm is not previously blacklisted by any government or semi-government Organization is required to be submitted. Any false information submitted shall make the firm liable for depriving from instant & future contracts in NHA.
 6. National Highway Authority reserves the right to reject any or all the bids assigning the reasons thereof.
