Subject: **VIOLATION OF PUBLIC PROCUREMENT RULES 2004, GENERAL MANAGER (REVENUE) NATIONAL HIGHWAY AUTHORITY ISLAMABAD's TENDER NOTICE FOR MISCELLANEOUS SERVICES**

Reff: *Please refer to your letter No. TL17/1705/8A dated 17th May, 2017*

NHA extremely appreciate the efforts and vigilant role being played by Transparency International across the board application of rule of law and ensuring transparency in public procurement process. At the same time, NHA would like to clarify that during public procurement process equal opportunity would be provided to all the prospective bidders to ensure transparency.

2. Through above referred letter, following objections has been raised on last line of Para-1 of said NIT dated 13th May, 2017 which states,

“ NHA can decrease number of toll plazas before submission of bid”
(copy enclosed)


Following observation is raised on the above lines.

“ Any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under rules”

3. In this regard, it is submitted that any change in the quantity before submission of bid(s) is covered under PPRA rules by providing equal opportunity to all bidders through publication of corrigendum. However, it may be noted that no such reduction in number of Toll Plazas has been made before submission of bids. Also no such change shall be made after bid opening as per above advise.

4. NHA assures the strict adherence to PPRA rules during above procurement.

- * The Number of Toll Plazas can be decreased by NHA before submission of bid.
- Bidding will be carried out by adopting "Single Stage Two Envelope" procedure.
 - Bidders are required to be registered with Pakistan Engineering Council (PEC) in Operator Category "O" as mentioned in the Bidding Documents for the year 2017, as well as possess NTN/STN and is on ATL of FBR.
 - Bid Security in the form and amount for the validity period as mentioned in bidding Documents must be accompanied with "Financial Bid".
 - The bidder(s) who are in default with NHA or any other Govt. Department are not eligible to participate in the bidding process. However, the bidder(s) whose case are/is already sub-judice or dispute/arbitration is in process at NHA, shall not be treated as defaulter(s) and will be considered for bidding on case to case basis subject to the approval of NHA.
 - Bidding Documents can be downloaded from NHA Website (www.nha.gov.pk) w.e.f. 15-05-2017. This advertisement is also available on NHA and PPRA websites.
 - All bidders are requested to submit, at the time of bid submission, Written Confirmation (Power of Attorney) authorizing the person to submit the bid. Written confirmation from owner/head, authorizing the signatory of the Bid to sign the Bid must also be accompanied with the "Technical Bid"
 - Sealed bids containing both Technical and Financial bids in separate envelopes shall be received in NHA Auditorium Islamabad on 30 May, 2017 until 1100 Hrs. The Envelope containing Technical Bid will be opened on same day at 1130 Hrs in the presence of the bidders/authorized representative (who wishes to attend). Financial Bids of only technically qualified bidders shall be opened on 13th June, 2017 (Tuesday) at the same venue and time.
 - The bidder shall provide an undertaking on Judicial Stamp paper duly notarized that the bidder is not defaulter of any Govt. Department including NHA, as well as not blacklisted anywhere from Pakistan.
 - The bidders providing unsubstantiated and / or incorrect information are liable to legal action and disqualification.
 - The Authority reserves the right to reject any/all bids at any time prior to the acceptance of a bid in accordance with PPRA's Rules 2004 (as amended in 2008).
