Dear Sir,

The Oil & Gas Development Company Limited Islamabad's tender notice for the upliftment / sale of Liquid Petroleum Gas published in daily "Dawn" on 15th April 2011, is against the Rule no. 16 [2] of the Public Procurement Rules 2004, as Rs. 25,000 being the price of for the purchase of tender documents is not allowed.

According to the rule the price should not be more than the cost of printing and providing documents. Rule is quoted below for your information;

16. Pre-qualification process.-

(2) The procuring agency shall provide a set of pre-qualification documents to any supplier or contractor, on request and subject to payment of price, if any.

Explanation.- For the purposes of this sub-rule price means the cost of printing and providing the documents only.

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures.

TENDER NOTICE

UPLIFTMENT / SALE OF LIQUID PETROLEUM GAS (LPG) FROM PPL'S ADHI FIELD (ADDITIONAL OGDCL'S SHARE)

Applications are invited from LPG Marketing Companies holding valid LPG Marketing Licenses from Regulatory Body (OGRA) for the sale / upliftment of additional OGDCL's LPG Share (approximately 45 tons / day) from Adhi Field Tehsil Gujjar Khan, District Rawalpindi.

- OGDCL intends to allocate LPG on the basis of Signature Bonus payable by the successful Company prior to signing of the Sale / Purchase Agreement (SPA) with OGDCL in a transparent manner.
- The arrangement for upliftment of LPG through the bidders would only be for a limited period of six months. During the said period, the Buyer shall have to set up its independent LPG bottling / storage facilities for receiving deliveries of LPG through pipeline arrangements.
- The sale / allocation of LPG will be made for a lot of 05 tons / day at the maximum each for a maximum contract period of 05 years (subject to reservoir behavior) on the basis of Signature Bonus. The marketing company offering the highest signature bonus will be declared successful for each lot. Other bidders in order of signature bonus offered will be advised to match the price of the highest bidder so that additional quantity of LPG approximately 45 metric tons produced by the seller is lifted by the buyers accordingly.
- OGDCL will charge applicable price per Metric Ton in Pak Rupees as determined from time to time from all LPG buyer in line with LPG Producer Pricing Policy.
- Upon signing of the SPA, the Buyer will provide a cash deposit totaling the value of 30 days of LPG supplies and a Bank Guarantee also totaling the value of 30 days of LPG supplies apart from the Signature Bonus.
- The interested applicants may obtain tender documents / instructions to bidders (ITB) on any working day (Monday to Friday) between 0900 to 1200 hours on payment of Rs.25000/- (non-refundable) through Pay Order / Demand Draft in favour of OGDCL from the address mentioned hereunder.
- Each Marketing Company will be entitled to bid for and lift only one lot of 05 tons per day.
- A Company from a group of companies / affiliates or holding interest, if successful for one lot, will be restricted to the same and no other company of the same group or affiliate or interest will be considered separately for allocation on an independent basis.
- All successful bidders will be asked to match the highest Signature Bonus offer received during the bidding process. In case, any bidder who would submit a lower Signature Bonus for the lot but was not willing to match the highest offer will automatically forego his right and his lot will be given to the highest bidder.
- The seller will have the right to annul the bidding process without assigning any reason.
- In case of shortfall or uneven production, the lot size will be adjusted amongst all the successful bidders evenly.
- The application for the sale / allotment of LPG may be submitted latest by 1100 hours on 02-05-2011, in sealed envelopes addressed to the General Manager (Commercial), OGDCL House, 9th Floor, Jinnah Avenue, Blue Area, Islamabad Pakistan.
- The bid documents shall be opened the same day i.e. 02-05-2011 at 1130 hours.

Incomplete applications will not be entertained / considered. OGDCL reserves the right to accept or reject any or all applications without assigning any reason thereof.
