Sub: Violation of Public Procurement Rules 2004, Manager of Pakistan National Shipping Corporation's Tender Notice for Acquisition of Two Tankers.  
PNSC closing dated was 29-11-2013

Dear Sir,

This is with reference to PNSC reply dated 28-10-2013 on the violation of PPRA Rules in the Tender Notice, published in daily "Dawn" on 24<sup>th</sup> October 2013.

TI Pakistan as informed that the closing dated of the tender was 29-11-2013, and tender opening was supposed to be opened on same day.

It is reported to TI Pakistan that Mr Aftab Siddiqui, Executive Director, Commercial, Mr. Imtiaz Abgotawala ED, Mr Zaheer Babar Quershi, ED and Brig R. Rashid Qureshi, are who was granted illegal contract appointment over 60 years age annually, for last 7 years, has been illegally processing the Acquisition of Two Tankers, after 7 months of the tender opening.


Second hand Tankers are not readily available in market. The quoted prices are normally of validity of 15 to 30 days. How can the process opened, ( if publically opened by PNSC, as the evaluation report is not posted on PNSC nor PPRA website) .

Why PNSC with allegedly illegal contract officers is processing the Tanker now on fast track basis. Kindly note that Secretary P&S vide letter dated 13 June 2014 has declared all Contract appointments after June 2013, as well as those of over 60 year age as void and illegal.

The Chairman is requested to follow PPRA Rules and terminate the procurement process of 7-8 months old tender, and re invite the tenders, with condition that quoted prices shall be certified accompanied with a current valuation certificate issued by international classification society, e.g. Lloyd, Etc. .

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
