Sub: Violation of Public Procurement Rules 2004, Director, Postal Life Insurance, Lahore's Pre-Qualification Notice for Building/ Civil Works of Postal Buildings.

Dear Sir,

This is with reference to Postal Life Insurance, Lahore's Pre-Qualification Notice published in daily "Express" on 4<sup>th</sup> December, 2016. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

The advertisement does not clearly specify the provision of pre-qualification document for the applicants that includes evaluation criteria, whereas according to Rule No. 16 (1) (2) of PPRA Rules 2004, it is mandatory to provide a set of prequalification document. Stated as under:


**16. Pre-qualification process.-** (1) *The procuring agency engaging in pre-qualification shall announce, in the pre-qualification documents, all information required for pre-qualification including instructions for preparation and submission of the pre-qualification documents, evaluation criteria, list of documentary evidence required by suppliers or contractors to demonstrate their respective qualifications and any other information that the procuring agency deems necessary for pre-qualification.*

(2) *The procuring agency shall provide a set of pre-qualification documents to any supplier or contractor, on request and subject to payment of price, if any.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.
