**Sub: Violation of Public Procurement Rules 2004, Secretary, Port Qasim Authority (PQA),
Karachi's Pre-Qualification Notice for Miscellaneous Works.**

Dear Sir,

This is with reference to Port Qasim Authority, Karachi's Pre-Qualification Notice published in daily "Dawn" on 20th June, 2018. It is observed that the advertisement is in violation of the PPRA Rules 2004.

As per advertisement "Port Qasim Authority reserves the right to accept or reject any or all proposals without assigning any reason thereof and no claim whatsoever will be entertained in this regard." It is a violation of Rule No.16 (4) of PPRA Rules, as per the rule the reason of rejection should be communicated to the applicants. Stated as under;

16. Pre-qualification process.- (4) The procuring agency shall communicate to those suppliers or contractors who have not been pre-qualified the reasons for not pre-qualifying them.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the pre-qualification notice under the prescribed procedures or issue a corrigendum and extend date accordingly.
