Subject:- TERMS AND CONDITIONS OF TENDER FOR RATE RUNNING CONTRACT FOR SUPPLY OF HOSPITAL ITEMS / MEDICINES.

Dear Sir,

Refer letter No. Nil dated 04.07.2013 by Transparency International Pakistan regarding "Violation of Public Procurement Rules 2004, General Manager (Medical), Pakistan Steel's Tender Notice for supply of hospital items / medicines".

2. The point wise response to the queries raised in the letter are given for kind perusal please:-

- i. "Pakistan Steel reserves the right to split the quantity and / or type of product(s) among more than one bidder". In this regard, it is to state that this term / condition was induced to procure and avail a better choice in quality and economy point of view according to PPRA Rule No. 4 "Principles of Procurement". As far as the violation of PPRA Rule No. 9 is concerned it is to mention here that Pakistan Steel Hospital has not made any splitting and regrouping in the annual demand of the hospital since the tender was invited according to our requirement by fulfilling PPRA Rule No. 23 proceeding to evaluation of bids which will be made as per PPRA Rule No. 29 and 30.
- ii. "Pakistan Steel reserves the right to accept or reject any or all bids without assigning any reason thereof". This clause is in line as per PPRA Rule No. 33. In this regard if a bidder wants to know about the reason of rejection it may be responded without justifying the grounds according to the rules. So this additional sentence is being incorporated in the tender terms and condition instead of re-inviting the tender in order to save the tendering expenditure in the interest of Pakistan Steel. This explanation is also being published through press corrigendum.
- iii. "Pakistan Steel has restricted the bidder to provide pay order only. In this regard to facilitate the bidders we can accept other option of tender Bank Guarantee by approved Banks which is also in accordance with our current practice of tendering process and will be published through press corrigendum. Moreover with reference clause No. IB.15 Bid Security indicated by Transparency International of Pakistan, the Finance Deptt may be coordinated for guidance and further process accordingly please.

CLAUSE NO. 09

The quotation will be opened on the same day at 10:30 AM in the office of undersigned in the presence of bidders who may wish to be present.
