Sub: Violation of Public Procurement Rules 2004, General Manager (Purchase), Pakistan Security Printing Corporation (Pvt.) Limited, Karachi's Tender Notices for Supply, Installation, Training and Commissioning of Banknote Numbering and Vanishing Machine, Banknote Intaglio Printing Machine, Single Note Numbering and Finishing Machine, Banknote Finishing and Packing Machine (Non-Collating).

Dear Sir,

This is with reference to Pakistan Security Printing Corporation (Pvt.) Limited, Karachi's Tender Notices published in daily "Dawn" on 31st March, 2017. It is observed that the advertisements are in violation of the PPRA Rules 2004.

The bidding document fee is charged as PRs 105,000/- or US \$ 1000/- in the advertisements, which appears costly in light of the Public Procurement Rules 2004. Stated as under;

25. Bidding documents. – (5) The procuring agency shall provide a set of bidding documents to any supplier or contractor, on request and subject to payment of price, if any.

Explanation - For the purpose of this sub-rule price means the cost of printing and providing the documents only.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tenders under the prescribed procedures or issue a corrigendum and extend date accordingly.
