Sub: Violation of Public Procurement Rules, 2004 Pakistan Public Works Department, Tender Notice for maintenance work.

Dear Sir,

The Pakistan Public Works Department's tender notice for the maintenance work published in daily "Express" and "The News" on 14th April 2011, is against the Public Procurement Rules 2004, as minimum period of 15 days is mandatory to submit applications from the date of publication of advertisement notice in press, whereas you have made no mention of the response time, which is a violation of rules. Rule is quoted below for your information:

13. Response time.-

The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice. keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

All advertisements or notices shall expressly mention the response time allowed for that particular procurement along with the information for collection of bid documents which shall be issued till a given date, allowing sufficient time to complete and submit the bid by the closing date:

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures.
