Dear Sir,

This refers your subject tender.

To our surprise the subject tender has been scrapped, though our corrected lowest bid of Rs. 378, 341,780/- (Option-1) and Rs. 354,827,871/- (Option-2) was approximately Rs. 50,000,000/- (RUPEES FIFTY MILLION) less than other bidders.

In this connection kindly refer clause 33(1) of PPRA rules, you are requested to kindly intimate the reasons for scrapping the tender.

It may be noted that Notice of rejection should have been intimated promptly vide clause 33 (3). In order to facilitate us for re-bidding, the same has been ignored, which is violation of PPRA rules & regulations.

We requested for issue of Tender documents for re-bidding, which has been denied on grounds that since we are not enlisted with PDW the tender documents cannot be issued, as confirmed on telephone by SDO, Mr. Ansari.

This is again gross violation of PPRA rules & regulations clause # 20 and 32 for open competitive bidding, and is obvious manipulations and malafide.

You are requested to constitute "redress of grievance committee" as per clause # 48 of PPRA rules to address the above objections and discriminatory terms and conditions advertised now for re-bidding.
