Detailed Report about the cited subject is hereunder:-

1. Tender Notice for subject matter published in the daily Urdu/English Newspapers on July 05, 2012 has the following grounds.
2. All possible details were communicated to the bidders for supply of required item. Also facility to visit the site and to monitor the installed Batteries in the system was also provided. Actually, these batteries are commonly used in UPS so we presumed that whoever participating in the Tender would be well – known about our demand.
3. As concerned to provide a set of **Bidding Documents** and to include **Bid Evaluation Criteria**, we were of the opinion that our Technical Data is quite sufficient as a replacement of Bidding Documents which will certainly assess the quality of batteries. Any bid, if it is exactly equivalent to our Data would be considered for financial proposal otherwise, we have no option but to reject it. It is our Evaluation Criteria and same is the reason we demanded 02 Envelop Bids. However, the lowest will be declared after firm prequalification.
4. It is pertinent to mention here that we tried our best to follow the PPRA Rules at the time of advertising the Tender. However, we admit that the procedure of "Bid Evaluation Criteria" was over-looked due to misunderstanding as mentioned in para-3.




