Sub: Violation of Public Procurement Rules 2004, In-charge (General Services), Principals Office, State Life Insurance Corporation of Pakistan, Karachi's Request for Proposal Notice for Hiring of NGO for Wider Enrolment.

Dear Sir,

This is with reference to State Life Insurance Corporation of Pakistan, Karachi's RFP Notice published in daily "Dawn" on 18th January, 2017. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per advertisement, "State Life reserves the right to accept/reject all the proposals of the respondents without assigning any reason". It is not complying with Rule No. 33 of PPRA Rules 2004, which requires that reason should be communicated to bidders. Stated as under:

***33. Rejection of bids:** - (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the RFP under the prescribed procedures or its new corrigendum and extend date accordingly.
