Sub: Violation of Public Procurement Rules 2004, Assistant General Manager, State Life Insurance's Tender Notice for Supply/Printing of Computer Stationeries TIP Letter dated 17<sup>th</sup> July 2012 and SLIC Letter dated 20<sup>th</sup> July 2012.

Dear Sir,

Transparency International Pakistan is in receipt of State Life Insurance Corporation of Pakistan's letter dated 20<sup>th</sup> July 2012 on the above subject.

SLIC has stated in its letter that "..Tender notice No. 09/2012 can be seen uploaded on the website of PPRA, <a href="www.ppra.org.pk">www.ppra.org.pk</a>, vide PPRA Tender No. TS160747E. on 16<sup>th</sup> July 2012". However, the attached screen shot displays the date 18<sup>th</sup> July 2012 i.e. one day after the publication of notice inviting tender in press.

TI-Pakistan staff had visited the Public Procurement Regulatory Authority and State Life Insurance websites but was unable to find the bidding documents on either of the sites. A screen shot of 17<sup>th</sup> July 2012 is attached for your reference of both the websites (Annex-A).

TI-P would also like to mention that according to the notice published in press, SLIC has invited bids for "the printing and supply of 15 different items" whereas the screen shot provided by SLIC only shows the tender for "Printing of receipts" (Annex-B). It should be noted that a procuring agency has to provide the bidding documents to the bidders immediately after the publication of the invitation to bid, in accordance with Rule 23 (1) of the Public Procurement Rules 2004, and a violation could deem the procurement to be declared as mis-procurement under Rule 50.

Kindly cancel the tender and re-invite it after completing the codal formalities.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.




