Sub: Violation of Public Procurement Rules 2004, Assistant Manager (P&GS), Vehari Zone,  
State Life Insurance Corporation of Pakistan's Tender Notice for Supply of Generator.

Dear Sir,

This is with reference to Vehari Zone, State Life Insurance Corporation of Pakistan's Tender Notice published in daily "Dunya" on 21<sup>st</sup> October, 2015. It is observed that the advertisement is in violation of the Public Procurement Rules 2004.

As per advertisement, "no response time is mentioned for the bidders, for the submission of proposal", and is a violation of PPRA Rules 2004, Rule No.13 (1). Stated as under;

*13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
