The In-charge Real State, State Life Corporation of Pakistan, Lahore's tender notice for security services of State Life buildings at Lahore, Faisalabad, Multan and Gujranwala, published in daily "Dawn" on 06<sup>th</sup> September 2011, is against the Public Procurement Rules 2004. The State Life Corporation of Pakistan has not mentioned anything about the bidding documents to be collected by bidders in the tender advertisement, which is a violation of Public Procurement Rules 2004. The rule is stated below for your reference;

**23. Bidding documents.**— (1) *Procuring agencies shall formulate precise and unambiguous bidding documents that shall be made available to the bidders immediately after the publication of the invitation to bid.*

The above information is forwarded for the purpose of avoiding the mis-procurement charge under Rule No 50, and with request to re-invite the tender under the prescribed procedures.
