SUBJECT: **BLATANT VIOLATION OF TENDER RULES & SANCTITY OF TRANSPORT TENDERS BY THE SINDH SOLID WASTE MANAGEMENT BOARD (SSWMB)**

It may be intimated that M/s Waste Master lodged a complaint to Sindh Public Procurement regulatory Authority (SPPRA) against the sanctity of procurement proceedings (NIT-2/2018-19). The SPPRA vide letter No.AD(L-II)/SPPRA/CMS-138/2018-19/2534, Karachi dated 20<sup>th</sup> March 2019 advised Sindh Solid Waste Management Board (SSWMB) to convene a meeting of 'Complaint Redressal Committee' (CRC) within stipulated time under the provision of SPPRA Rules, 2010 (amended up to date)

2. Pursuance to SPPRA advice, the meeting of CRC was convened on 29-03-2019 at 3:00 PM. However, the complainant deliberately did not attend the meeting despite proper service of meeting notice through TCS and electronic mail (copy attached), therefore the CRC unanimously dismissed the complaint with the advice that the complainant, if still feels aggrieved, he may approach 'Review Committee' as prescribed in SPPRA Rules, 2010 vide letter No.SSWMB/NIT-2/2018-19/948/2019 dated 2<sup>nd</sup> April 2019 against the decision of CRC.

3. Since the complainant is continuously hurling baseless allegations (copies attached) against the transparent procurement procedure in NIT-2/2018-19 and decision of the CRC; it is appropriate that matter may be placed before the 'Review Committee' being an Independent Apex Committee of CRC for final decision in the matter.
