 - ii. All safety arrangement should be taken at site to avoid any mishap.
 - iii. All other terms would be same as per agreement and terms and conditions of the contract mentioned in the BoQ of Bidding Document.
 - iv. Works completion program within stipulated time shall be submitted within 04 (Four) days of receipt of this work order.
 - v. A proper display board with pre-approved text by competent authority i.e. Director / Deputy Director (Front End - South), Sindh Solid Waste Management Board Karachi should be installed and maintained by the contractor throughout the contractual period.
 - vi. In case of any un-necessary delay in execution of work, penalty shall be imposed on the contractor as per SPPRA rules / terms and conditions of the contract.
