2. you are directed to carryout the work during stipulated time period as mentioned in Bidding Document and agreed / offered / accepted by your company in the bid along with the terms and conditions and Contract Agreement.
3. The Director (GTS), SSWMB will issue necessary instructions on day-to-day basis for carrying out the works / services awarded to you.
4. You are further directed to take the following measure at the site during execution:
 - i. Professional expert should be present at site along with site supervisor till the completion of work.
 - ii. All safety arrangement should be taken at site and during transportation to avoid any mishap.
 - iii. All other terms would be same as per agreement and terms and conditions of the contract mentioned in the BoQ, Bidding Document and Contract Agreement.
 - iv. Works completion program within stipulated time shall be submitted within 04 (Four) days of receipt of this work order.
 - v. A proper display board with pre-approved text by competent authority i.e. Director (GTS), Sindh Solid Waste Management Board Karachi should be installed and maintained by the contractor throughout the contractual period.
 - vi. In case of any un-necessary delay in execution of work, penalty shall be imposed as per SPPRA rules / prescribed in the contract agreement.
