3. The Deputy Director (Front End Collection) DMC East, SSWMB will issue necessary instructions on day-to-day basis for carrying out the works / services awarded to you.
4. You are further directed to take the following measures at the site during execution:
 - i. Professional expert should be present at the site along with your site supervisor till the completion of work.
 - ii. All safety measure arrangements should be taken at site to avoid any mishap.
 - iii. All other terms would be same as per agreement and, terms and conditions of the contract mentioned in the BoQ of Bidding Document.
 - iv. Works completion program within stipulated time shall be submitted within 01 (One) day of receipt of this work order.
 - v. The contractor shall be required to lift, transport and dispose of each and every offal (including non-hazardous waste) at designated dump site from each and every area, i.e. main roads, link roads, streets, mohalla, societies, apartments, open places etc of the zone including loading / unloading haulage /transportation.
 - vi. A proper display board with pre-approved text by competent authority i.e. Director / Deputy Director (Front End, DMC East), Sindh Solid Waste Management Board Karachi should be installed and maintained by the contractor throughout the contractual period.
 - vii. In case of any un-necessary delay in execution of work, penalty shall be imposed on the contractor as per SPPRA rules / terms and conditions of the contract.
