Petitioner does not press this Petition, which is accordingly dismissed.

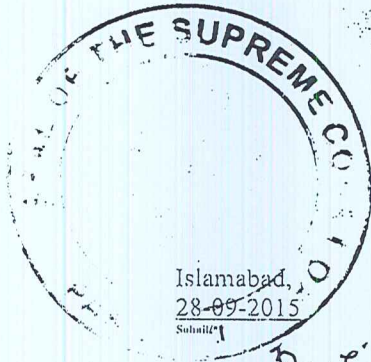
Civil Review Petition No.516/2014.

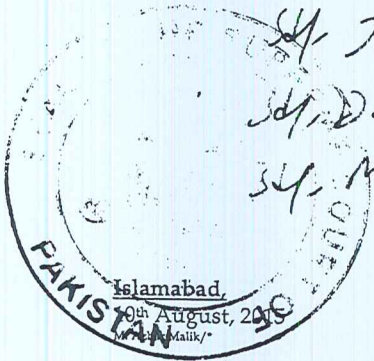
